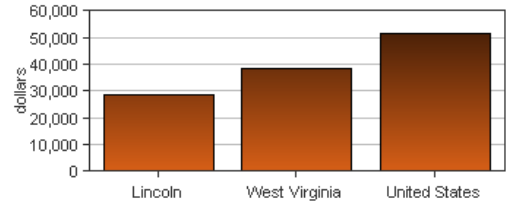
Personal income last published on November 15, 2018.

Lincoln is one of 55 counties in West Virginia. It is part of the Huntington-Ashland, WV-KY-OH Metropolitan Statistical Area. Its 2017 population of 20,825 ranked 31st in the state.

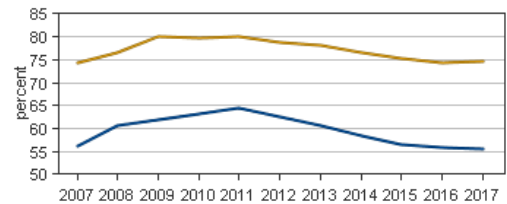
Per Capita Personal Income

In 2017, Lincoln had a per capita personal income (PCPI) of \$28,665. This PCPI ranked 49th in the state and was 74 percent of the state average, \$38,479, and 56 percent of the national average, \$51,640. The 2017 PCPI reflected an increase of 2.9 percent from 2016. The 2016-2017 state change was 4.1 percent and the national change was 3.6 percent. In 2007, the PCPI of Lincoln was \$22,334 and ranked 47th in the state. The 2007-2017 compound annual growth rate of PCPI was 2.5 percent. The compound annual growth rate for the state was 2.7 percent and for the nation was 2.6 percent.

Personal Income

In 2017, Lincoln had a personal income of \$596,953.0*. This personal income ranked 32nd in the state and accounted for 0.9 percent of the state total. In 2007, the personal income of Lincoln was \$490,299.0* and ranked 31st in the state.

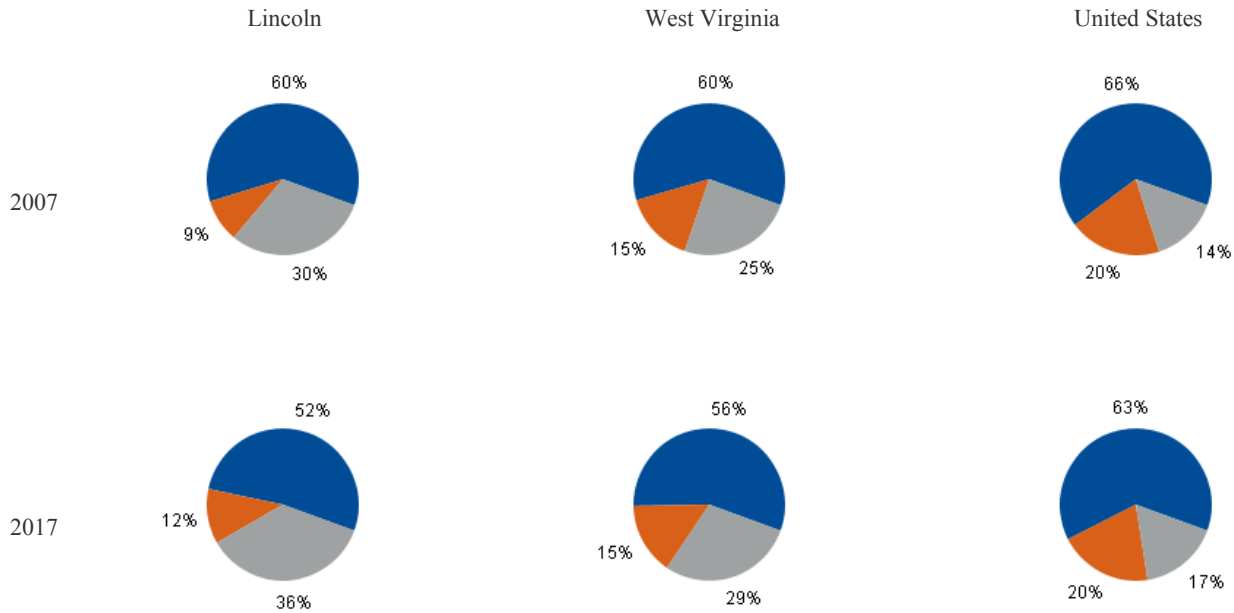
