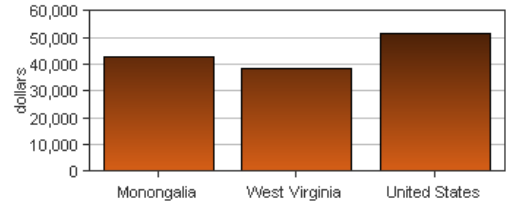
Personal income last published on November 15, 2018.

Monongalia is one of 55 counties in West Virginia. It is part of the Morgantown, WV Metropolitan Statistical Area. Its 2017 population of 105,030 ranked 3rd in the state.

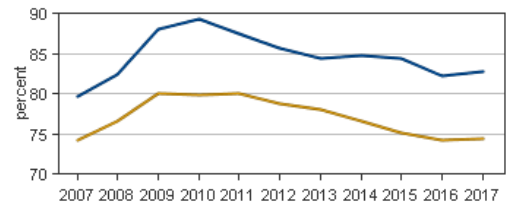
Per Capita Personal Income

In 2017, Monongalia had a per capita personal income (PCPI) of \$42,734. This PCPI ranked 6th in the state and was 111 percent of the state average, \$38,479, and 83 percent of the national average, \$51,640. The 2017 PCPI reflected an increase of 4.2 percent from 2016. The 2016-2017 state change was 4.1 percent and the national change was 3.6 percent. In 2007, the PCPI of Monongalia was \$31,793 and ranked 6th in the state. The 2007-2017 compound annual growth rate of PCPI was 3.0 percent. The compound annual growth rate for the state was 2.7 percent and for the nation was 2.6 percent.

Personal Income

In 2017, Monongalia had a personal income of \$4,488,343.0*. This personal income ranked 3rd in the state and accounted for 6.4 percent of the state total. In 2007, the personal income of Monongalia was \$2,885,631.0* and ranked 4th in the state.

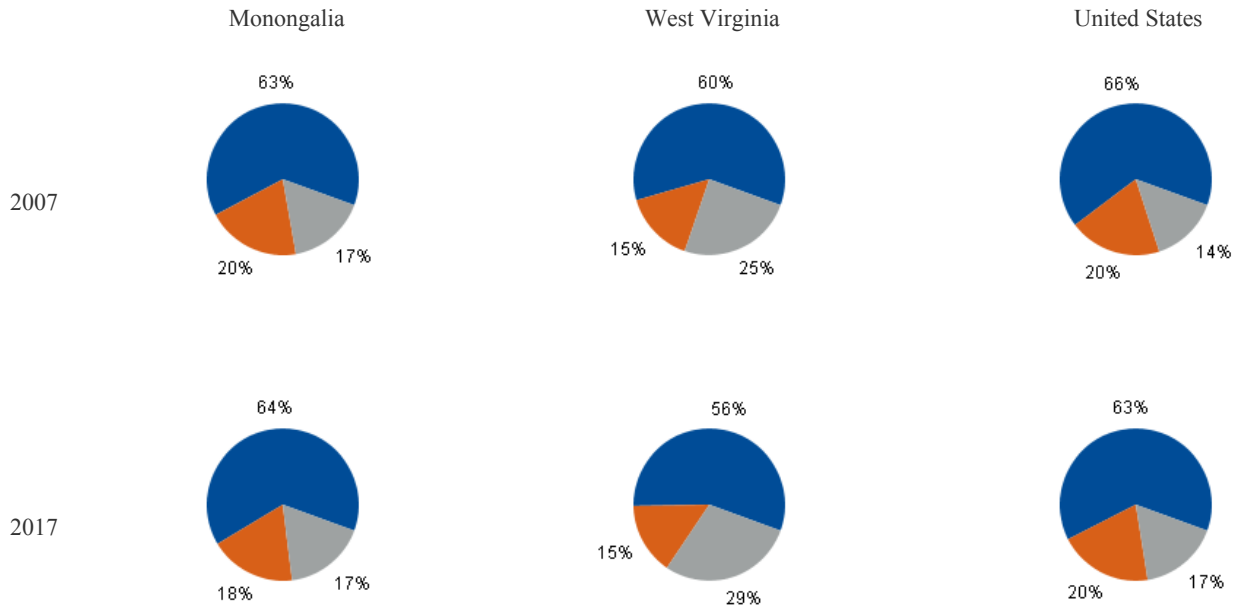
