



# Ritchie , West Virginia

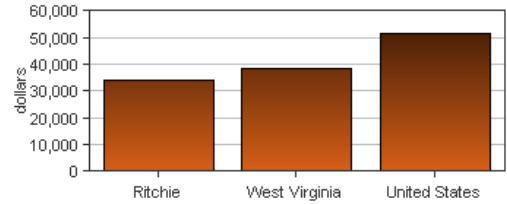
Personal income last published on November 15, 2018.

Ritchie is one of 55 counties in West Virginia. It is not part of a metropolitan area. Its 2017 population of 9,774 ranked 44th in the state.

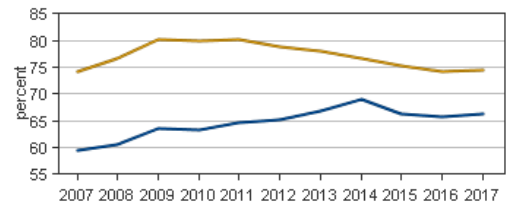
## Per Capita Personal Income

In 2017, Ritchie had a per capita personal income (PCPI) of \$34,252. This PCPI ranked 28th in the state and was 89 percent of the state average, \$38,479, and 66 percent of the national average, \$51,640. The 2017 PCPI reflected an increase of 4.3 percent from 2016. The 2016-2017 state change was 4.1 percent and the national change was 3.6 percent. In 2007, the PCPI of Ritchie was \$23,688 and ranked 41st in the state. The 2007-2017 compound annual growth rate of PCPI was 3.8 percent. The compound annual growth rate for the state was 2.7 percent and for the nation was 2.6 percent.

## Personal Income

In 2017, Ritchie had a personal income of \$334,775.0\*. This personal income ranked 44th in the state and accounted for 0.5 percent of the state total. In 2007, the personal income of Ritchie was \$250,093.0\* and ranked 44th in the state.

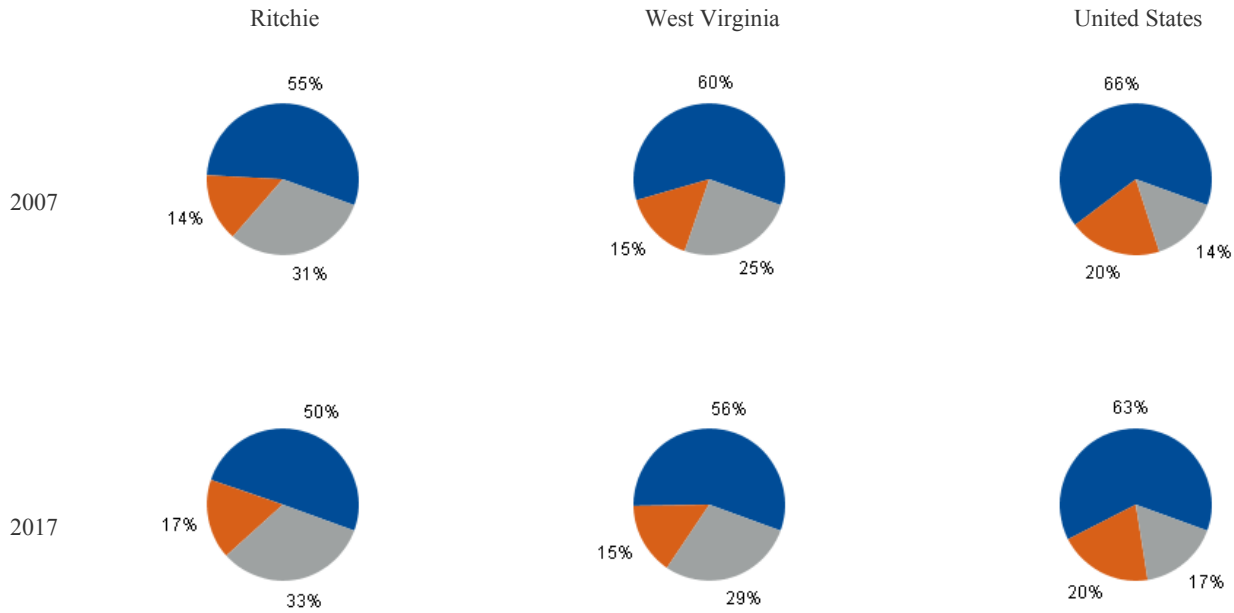
