

# Mason , West Virginia

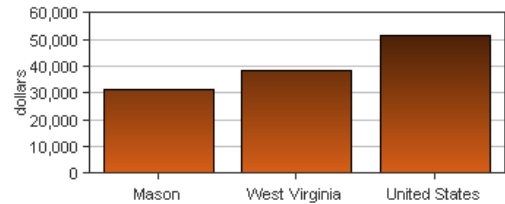
Personal income last published on November 15, 2018.

Mason is one of 55 counties in West Virginia. It is part of the Point Pleasant, WV-OH Micropolitan Statistical Area. Its 2017 population of 26,801 ranked 23rd in the state.

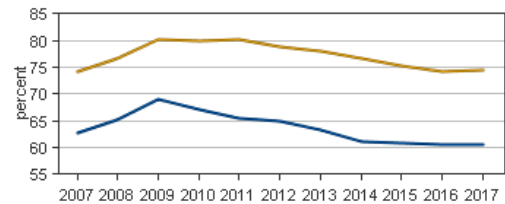
## Per Capita Personal Income

In 2017, Mason had a per capita personal income (PCPI) of \$31,359. This PCPI ranked 40th in the state and was 81 percent of the state average, \$38,479, and 61 percent of the national average, \$51,640. The 2017 PCPI reflected an increase of 3.6 percent from 2016. The 2016-2017 state change was 4.1 percent and the national change was 3.6 percent. In 2007, the PCPI of Mason was \$25,029 and ranked 34th in the state. The 2007-2017 compound annual growth rate of PCPI was 2.3 percent. The compound annual growth rate for the state was 2.7 percent and for the nation was 2.6 percent.

## Personal Income

In 2017, Mason had a personal income of \$840,465.0\*. This personal income ranked 24th in the state and accounted for 1.2 percent of the state total. In 2007, the personal income of Mason was \$669,213.0\* and ranked 26th in the state.

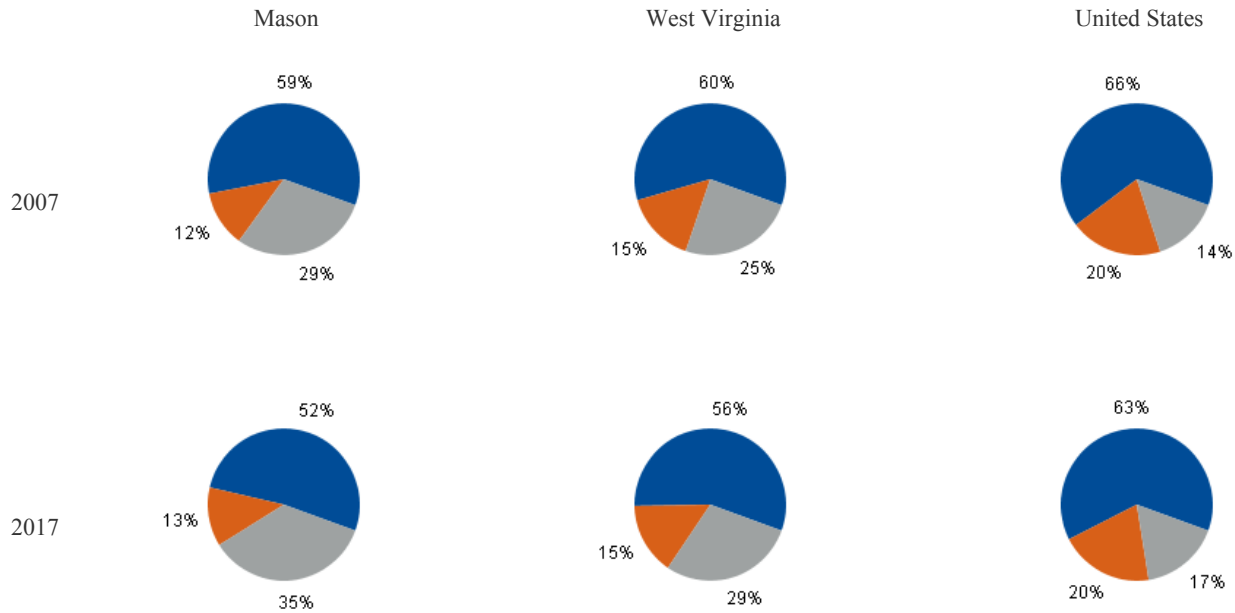
